UPDATE #14 COVID-19

Indian Creek Village Residents:

Miami-Dade County (MDC) has begun phasing into the "New Normal". Effective last Wednesday, April 29th, 2020, MDC issued Emergency Order 21-20, reopening, with restrictions, parks, golf courses, marinas and boat ramps. All MDC Emergency Orders must be adhered to by all MDC municipalities. Notwithstanding, MDC has allowed municipalities to be more restrictive than their current County Orders.

Therefore, effective Thursday, April 30th, 2020, the Village issued <u>Amendment No. 2 to Emergency Order No. 20-01</u> to allow golfing and tennis within the Country Club property with certain additional restrictions. Indian Creek Village- COVID-19 Drive-Thru Testing

As a result of the Village's COVID-19 drive-thru testing, administered by BioCollections Worldwide Inc. (BCW) on April 23rd and April 24th, 2020, a total of 130 were tested and none of these test results were positive.
